We will ask you to provide us with your name and surname, telephone number and e-mail address. We will send you an e-mail with booking confirmation or instructions on how to complete the booking and payment. Your personal data, which is processed online, is transmitted via SSL protocol. The SSL protocol allows your personal data to be encrypted and travel securely over the internet. Encryption is activated before the transfer of personal data starts. You will know that you are in the secure state, when a symbol of a locked padlock in the address bar on your browser. In addition, upon entering the secure state, the first characters on the website change from "http" to https" and your personal data is behind the so-called firewall, protected against any external access. We need your telephone number and e-mail address so that we can confirm your reservation and contact you in case of any particularities regarding your reservation. We may also use your e-mail to ask for your opinion, which is extremely important to us.

If you have subscribed to our e-news you have given us permission to use information about your booking or travel in order to prepare personalized offers for you. Unsubscribing from enews (cancellation of consent or objection) can be done at any time by clicking the unsubscribe link in the received e-news or by writing to our address.

Cookies
